PURPOSE

A. OPD Services

- **Exclusion:** D&C (Drugs & Consumables) and related charges shall not be eligible for discount.

B. Delivery Packages

- **15% Discount** on all maternity and delivery packages, including:
 - Normal Delivery Package
 - Caesarean Section (LSCS) Package
- **Exclusion:** D&C charges shall not be eligible for discount.

C. IPD Services

- **15% Discount** on the total In-Patient Department (IPD) hospital bill.
- Applicable on room charges, nursing charges, investigations, procedures, and other hospital services.
- **Exclusion:** D&C procedures and related charges shall not be eligible for discount.

VALIDITY

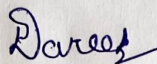
This MOU shall remain valid for a period of **One (1) Year** from the date of signing and may be renewed upon mutual consent of both parties.

TERMS & CONDITIONS

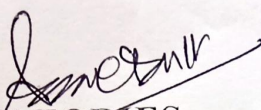
1. Discounts shall be applicable only upon presentation of a valid ICMAI membership/staff identity card.

3. The discount shall be applicable only on services rendered by Hope Hospital.

NON-BINDING NATURE

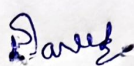
This agreement is intended to record the understanding between the parties and does not create any legal partnership, agency, or employment relationship between them.
